Fee Installment Program

A registration fee payment plan is offered in three monthly installments with a participation fee. Apply for PACE on ZOT Account at https://zotaccount.uci.edu and activate your plan by making an electronic payment from the Current Account view.

Fees and Tuition Payment Due Dates

Fall 2025 September 15, 2025
Winter 2026 December 15, 2025
Spring 2026

Payment must be received by mail, or in the drop box at Aldrich Hall by 4 pm. Electronic payment is due by 5 pm.

We strongly encourage that payment be made electronically. If fees are paid by mail, we recommend sending them at least 10 days before the payment due date. Postmarks are **not** considered.

ZOT Account Information

Students should view Student Billing information on ZOT Account at https://zotaccount.uci.edu.

Financial aid awards will be displayed on the account once the award has been accepted and applicable promissory notes are signed and returned to the Office of Financial Aid and Scholarships. When a financial hold has been put on your account, a notice will appear on the account.

Monthly Payment Schedule

Payments are due on the 15th of every month. Payment must be received by mail or drop box by 4PM or electronically by 5 PM. If the 15th falls on a weekend or a holiday, payment is due the next business day.

Review your ZOT Account for housing due dates which may be due before the 15th.

Late Fee Payment at the Deadline?

Students who do not meet the fee payment deadline lose all of their class enrollments. There is no guarantee there will be space available when re-enrolling.

A **FINANCIAL HOLD** is placed on student accounts for past due amounts, which also holds registration, and financial aid.

DEFT for Electronic Refunds

Disbursement Electronic Funds Transfer

Students are encouraged to sign up for DEFT—this allows money owed to them by UCI (credits; financial aid; paychecks for on-campus jobs; etc.) to be deposited directly into their bank account. This process is faster than waiting for a paper check. DEFT sign-ups are available at:

Navigating the Details

The eTech Fee

The eTech Fee is a nonrefundable per-unit fee. The fee is used to fund the UC Irvine Educational Technology Initiative maintaining and improving existing educational technology and providing new educational technology services and capabilities supporting the educational goals of UCI students.

E-tech fees are assessed after the third week of instruction. Students should check their ZOT Account frequently to ensure they see updated billing and due date information.

Health Insurance

Student Privacy & University Policy

Under the Family Educational Right to Privacy Act (FERPA) and UC policy, registered students have the right to keep their educational records private. At UC Irvine, privacy rights begin at the time a student submits his Statement of Intent to Register (SIR). A student may wish to allow their financial information to be discussed with another individual (a parent or guardian, for example). The student can e-mail cbs@uci.edu (from their UCI e-mail) with their full name and student ID number, indicating that they would like to give permission to said individual. CBS will send the authorization form to the student via DocuSign for processing.
